GENERAL CLEANING INSTRUCTIONS

- Clorox® Bathroom Cleaner with Teflon®
- Lime-a-Way Bathroom Cleaner
- Soft Scrub® Lemon Cleanser
- Tilex® Soap Scum Remover
- Windex®
- Comet® Bathroom Cleaner with Disinfectant
- Lysol® Basin, Tub & Tile Cleaner
- Soft Scrub® with Bleach Cleanser
- Vim® Cream Cleanser
- Scrubbing Bubbles® Soap Scum Remover

- Abrasive cleaners such as Ajax®, Comet®, rouge and cerium oxide
- Hydrofluoric and phosphoric acids
- Abrasive brushes, razor blades and other sharp objects which may scratch the coating or glass

Soft Water	Water spots come off with soap and water	Any glass cleaner	Windex® non shower side	As needed
Hard Water	Water spots are removed with vinegar	Any acidic glass cleaner	Solution of 50% vinegar and 50% water	Approximately once every 15 showers
Hard Water with dissolved silica	Water spots are not removed with vinegar	Cleansers with mild abrasives	Soft Scrub® Lemon, Kaboom® Shower Tub & Tile	Approximately once every 15 showers

Cleaning frequency recommendations are guidelines only. Actual cleaning frequency will depend upon humidity, degree of water hardness, shower temperature and other variables. In cases with extremely high silica content, it may be useful to squeegee as needed between cleanings.

VISTASHIELD® COATED GLASS 10 YEAR LIMITED WARRANTY

What is Warranted and For How Long

When installed in a residential home and regularly maintained according to VistaShield®'s recommendations according to water type, VistaShield® treated glass is warranted to the original end-user customer to be free from visible staining, corrosion, or discoloration for 10 years from the date of purchase. Liability under this warranty is limited to VistaShield®'s exclusive option to reapply the VistaShield® product — no glass will be replaced.

Who is Covered

The limited warranty extends only to the original end-user VistaShield® customer and is non-transferable. "Original end-user customer" includes direct purchaser, a consumer who contracts for VistaShield® for the consumer's residence through a remodeler or contractor, and the first occupant of a newly constructed residence that contains VistaShield® as part of the original construction. This limited warranty and the registration requirement below apply to VistaShield® purchases of May 1, 2010.

Limitations

The limited warranty does not cover scratches, chips, breakage or claims for glass that has been discarded or destroyed before an authorized VistaShield® representative has inspected it. This limited warranty is void if the VistaShield® glass is damaged by accident, improper use, failure to follow VistaShield® recommended cleaning, installation, or handling procedures, or if there are causes outside VistaShield®'s control, or if the product is altered in any way. Labor to reapply VistaShield® is not covered by this 10 year warranty. Any warranties implied by law are limited to the duration of the 10 year limited warranty. Except for the limited warranty stated here, there are no express or implied warranties of any kind and no warranties of merchantability or fitness for particular purpose, and no warranty shall be implied by operation of law or otherwise. In no event shall VistaShield® be liable for indirect, special, incidental, or consequential damages of any kind.

Your Rights Under State Law

Some states do not allow limitation on implied warranties or the exclusion or limitation of incidental or consequential damages, so the above exclusions or limitations may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights that vary from state to state.
